This will allow us to match and sometimes beat prices listed by online retailers. This will also include prescription items. With the planned increase use of direct drop-shipping, we have decided to discontinue the use of our online store. Over the past few years, we have seen a steady decline in online store usage and a steady increase in the taxes, fees, and online service charges. It was not making sense for us to continue to offer this service moving forward. Another goal for 2021 is to update our client tax information so we are compliant with the State Tax Codes. This will include completing a ST-105 tax exempt form for all our livestock producers that qualify for any/all tax exemptions associated with livestock production through the agriculture exemptions. We will be contacting our clients in the next couple of months to get these records updated.
